Highway Report:

Cemetaries mowed three times.

All plows washed and put away.

Bathroom in park complete except for the door.

Guardrails on Jones Rd fixed, and state approved.

Councilwoman Susan Korosec would like to put on July's agenda to discuss the Jones Rd bridge at more length. Councilman Robert Royce to ask around for an engineer.

All sides of road got mowed.

Started hauling sand for winter.

Pad is installed for building to house loader.

Highway Dept thanks for the town for the mowers.

The culver on Rose Rd washed out, fixed now.

Park Commissioner Report:

Park is open for main events.

Bathrooms fixed.

Codes Enforcement Report:

Issued 4 permits- 1 Septic/ 2 Rooftop Solar/ 1 deck removal and replacement.

Supervisor William Miller received notice that Excellus BCBS requested a rate increase from the state.

Herkimer Co Industrial Development Agency is considering revising the existing policy. Mike Connors looking further into. Discussion ensued.

The Village of Winfield will be the lead agent for the Ambulance. Discussion ensued.

Supervisor William Miller to negotiate a new contract with the fire department.

There will be a public hearing regarding the Delaware Solar project. It will be held 7/9/25 at 6:00 prior to the regular town meeting. Notice will be placed in the post office.

An approval was made to open a new bank account with Wayne Bank specifically for the solar project.

Motion to approve was made by Councilwoman Susan Korosec and seconded by Councilman Michael Peo.

The motion was carried unanimously.

Looking at the possibility of charging or accepting donations for use of the pavilion next year. Also requiring a form signed stating it's their responsibility to clean up after their event and lock the bathroom door.

Board would like a copy of the schedules for the pavilion as well as a written report from the Parks Commissioner.

Supervisor William Miller has a meeting with NYSEG in the park as they can't find two meters.

Supervisor William Miller and Councilwoman Susan Korosec went through Safety Policy and sent to board. Discussion ensued and amendments were made.
