The minutes from the Regular Board Meeting held May 13, 2020 were read and edited by each Board Member present.

### SUPERVISOR'S REPORT:

- 1. Supervisor Osborn stated the Sexual Harassment Training is to be completed by all employees.
- Supervisor Osborn spoke with Teresa Cerminaro and reported that she currently has plenty of masks and disinfectant and expressed that she is busy with dogs that people drop off.

### CLERK'S REPORT:

1. Mrs. Donley reports 11 dog renewals, 2 marriage licenses and 6 building permits for May 2020.

# HIGHWAY SUPERINTENDENT'S REPORT:

- 1. Mr. Jones reports he received a letter from the State guaranteeing 80% of the CHIPS money. Due to the COVID-19 pandemic, there may be a 20% reduction.
- 2. Mr. Jones states the road work is almost complete.

### PARK COMMISSIONER'S REPORT:

- 1. Mr. Royce states that Pavilion #1 has 9 reservations, Pavilion #2 has 6 reservations and Pavilion #3 has 1 reservation scheduled during the months of June August 2020.
- 2. Mr. Royce advises the Alcohol Use In The Park signs on the gates need to be replaced.Supervisor Osborn will purchase the signs.
- 3. Mr. Royce reports that on June 9th he inspected the trees and all are fully leafed out.
- 4. Mr. Royce recorded the loss of 6 White Oaks, 6 Bur Oaks and 2 Red Maples.
  - ☐ Councilwoman Korosec will contact the State to ask if the remainder of the grant money is still available to purchase and plant 12-15 more trees.
- 5. Mr. Royce received a call expressing concern about spraying herbicide along the stream banks may be polluting downstream.

# CODES/ZONING OFFICER'S WRITTEN REPORT:

- 1. Mr. Donley is currently working on permit #17 for the year 2020.
- 2. Mr. Donley states he's continuing inspections on active permits.
- 3. Mr. Donley anticipates the reopening of the courts to pursue the Carpenter farm property of 51. On 6/9 he was driving by and nearly one dozen cows were loose and near the road. He stopped and no one came to the door, so Mr. Donley reported this to the State Police.

4. Mr. Donley reports a complaint on the Randy Schafer property on Route 51 North. Mr. Schafer was contacted and stated he has been a Licensed Scrap Dealer since 2009. Mr. Schafer was behind due to COVID-19, the scrap yards were closed, however he was currently hauling loads out. Mr Schafer also noted that he does not dismantle anything on his property.

#### ZONING BOARD OF APPEALS:

- 1. Mr. Watkins states there will be a Public Meeting on June 17th at 7:00 PM via Zoom. The meeting ID and password will be posted in the West Winfield Star. The purpose of the meeting is to discuss the application of Wayne Jennison to build a 40 x 60 Commercial Pole Barn with office space on 266 Stone Road West Winfield which is now zoned Residential/Agriculture. Public meeting is being held for the second time due to the question whether or not quorum was present at the first meeting. Confirmation is needed if there's three or five people on the ZBA.
- 2. Mr. Watkins questioned how many people are actually on the ZBA three or five? Councilman Kulczak states there are three people listed on the ZBA according to the Organizational Meeting Minutes from January 15, 2020. The three people listed are Keith Watkins, Cathy Smith & Carl Wheat.
- 3. Mr. Watkins has 3 people that have expressed interest in sitting on the Zoning Board of Appeals.

## **OLD BUSINESS:**

Greg Rogers was present to discuss his interest in purchasing .6 acres of land behind his residence at 406 Curtis Avenue and Clapson Road where his garage is located which is partially on town property. The garage was there when he purchased the house. He expressed his intentions are to clean up the property and remove the overgrown bamboo to make it mowable and usable. He does not plan to build anything on the property. Mr. Osborn has reached out to Attorney Quinn on how to proceed with this matter. Mr. Osborn stated there will need to be a public meeting to discuss the sale. Due to liability reasons, Supervisor Osborn recommended that Mr. Rogers cease any Town property maintenance until a decision has been made.
