### PLANNING BOARD:

Looking for 8 volunteers to head steering committee. Different headings would be Education, transportation ect. Will be open to the public for volunteers to be under the steering committee. Need to publicize. Let Mike Peo know if you are interested. Councilman Rob Royce and Jay Kulczak showed interest.

This is a state grant. Clean Air Community is part of this grant.

## **OLD BUSINESS:**

Councilwoman Susan Korosec to meet with Christian to go through the website and clean it up. Suggested giving him a new zoning book to put on the website as a draft.

Suggested putting the laws on the website and cleaning it up.

Minutes from four months ago not showing up.

Councilwoman Susan Korosec and Town clerk Terri Atwell to get the process down to put minutes on the website.

If decide to go ahead, Chirs Osborn will be responsible for ALL fees. Will pay no less than appraisal price with boards discretion. Once Pre-work is done board needs to take a final vote

and set a final meeting for public hearing. County is ok with them putting in a driveway in that area. Councilman Mike Peo would like to see a better map of what he is looking at.

Councilwoman Susan Korosec advised that the village has recently been in contact with the Mohawk Valley Hometown Heroes banner program. Banners of Hometown Heroes go on telephone poles and stay up for three years. There is a payment form and deadlines if anyone is interested. They would like to get as many as they can. Flyers were passed out to all board members.
